The [draft priority actions](#) will determine what projects are eligible for FWCP funding and what work we will do together in the next few years to help conserve and enhance fish and wildlife in watersheds impacted by existing BC Hydro dams. Your input is important to us and will be considered as we finalize updated action plans by August 2020.

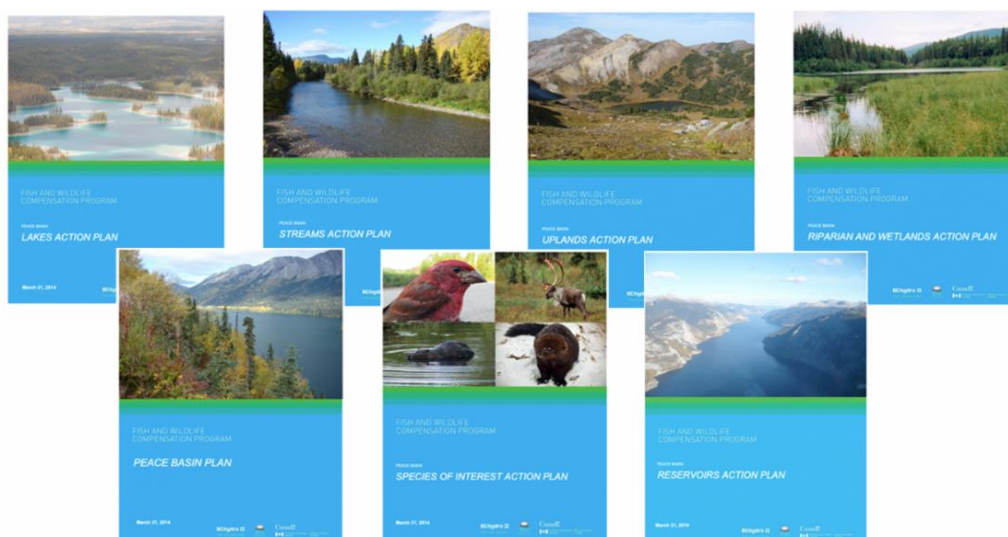

Action plans guide our projects

Our current Peace Region action plans were finalized in 2014, and have been used since then to guide more than \$7.1 million in project funding toward more than 114 projects. We will be announcing our Peace Region's 2020-2021 projects in the next few weeks. Across our three regions approximately \$8.7 million was approved for 99 fish and wildlife projects.
